

Flood in Southeast of Myanmar

Situation Report (Issue no.3: 22-Sep-2024)

CIDKP is collecting information of the flood affected areas and population in CIDKP's operation areas that cover 4 state/regions: East Bago, Kayin, Mon and Tanintharyi. The flood situation reports will be issued based on the collected data of CIDKP's district and township teams throughout the region.

Highlights

- The Typhoon Yagi swept through northern Vietnam, Laos, Thailand, and Myanmar in early September and caused severe floods, flashfloods, and landslides.
- Based on the collected information up to the date, **411** villages, **49,941** households (**259,397** persons) in Doo Tha Htu (Bilin), Taw Oo (Taungoo), Kler Lwe Htu (Nyaung Lay Pin), Bleed Dawei (Tanintharyi), Mu Traw (Hpa-Pun), Dooplaya, and Hpa-An districts were affected by the flood severely damaged the large scale of paddy fields, food storage facilities, water resources including shallow wells, hand-pump wells, and ponds, latrines, religious buildings, and community buildings. In addition, it also caused loss of livestock and poultry and even caused death of community members.

Humanitarian Needs

- Support for the food, drinking water, and hygiene kits are the emergency needs.
- Since most of the communities' farms were flooded one time in late July and early August of 2024 and the second time in mid of September 2024, it caused severe damage to paddy fields and late timing for the rehabilitation of the farms for this season.
- This time of flood destroyed desperately the farms, farm tools, vehicles, and machinery of the community members. They are in need of support for livelihood rehabilitation.
- Due to the flood, communities have lost thousands of poultry and livestock, and they are in need of support for restoring animal husbandry that is largely contributing to the domestic consumption and diversification of livelihoods.
- Thousands of hand-dug wells and shallow wells were drowned by the flood, and they need support for the recovery of the water facilities.
