NCCT members, KNU and KIO Technical Team members, Ethnic armed organisations observers and special invitees	From 20 to 25 January 2014, Armed Ethnic Groups met to consolidate their position in relation to a nationwide ceasefire. The meeting was to lay down the foundations of ethnic unity and produce a substantive set of requirements to ensure and secure a nationwide ceasefire in the country. The conference also reaffirmed the six main points necessary for ethnic groups to move towards peace in the country. These include: <ol style="list-style-type: none"> 1. A Nationwide Ceasefire Agreement 2. A Framework for Political Dialogue 3. A National Dialogue

Implementation of Accord <p>In addition to the six points, a number of other issues were raised including the use of terminology in the Nationwide Ceasefire Document when referring to the armed ethnic groups themselves. While the conference was able to accept the fact that the federal army issue and the creation of new states could be solved later, a number of groups maintained that they needed to keep the Burmese term “တော်လှန်ရေး” for revolutionary armed ethnic groups. This term, which can also mean reform, was originally dismissed by the NCCT for inclusion in earlier drafts, however, the conference participants insisted on reinstating it to the new draft.</p> <p>In total the main structure of the Law Khee Lar agreement is:</p> <ul style="list-style-type: none"> • Basic Principles • Aims and Objectives • Political roadmap • Military related issues • Code of Conduct • Nationwide Ceasefire Joint Monitoring • Trust Building and Waiver of Law on Unlawful Associations • Political dialogue • Transitional arrangements • General • Signing of the agreement

Chapter 1. Basic Principle. Chapter 2. Aims and Objectives. Chapter 3. Ceasefire Matters. Chapter 4. Methods to Consolidate the Ceasefire. Chapter 5 Guarantee for Political Dialogue. Chapter 6. Implementation. Chapter 7. Miscellaneous.</p> <p>Once both parties accept the Draft Nationwide Ceasefire Agreement it will be reviewed by Ethnic Armed Organisations, and once signed the political dialogue will begin.</p>

KNU representatives were P'doh Saw Kwe Htoo Win (KNU General Secretary and Leader of Single Text Drafting Team of NCCT) and P'doh Saw Tah Doh Moo (KNU CEC Member and Technical Team Leader).</p> <p>The objective of the meeting was to get consensus on the nationwide ceasefire document as close as possible while the wording and contents that still need to be negotiated further were left for the next meeting.</p>
