

## PRELIMINARY CEASEFIRE TALKS:

The Karen National Union is always looking for an opportunity to solve the conflict by political means. Because of this basic principle we have engaged in 5 previous ceasefire<sup>1</sup> talks that have broken. These ceasefire talks failed because the successive governments did not respond by political means to the negotiations.

After the new Burmese/Myanmar government established its office, President U Thein Sein on 30 March 2011 stated in his inaugural speech that he wanted to build national unity by addressing the decades of armed conflict with the ethnic nationalities. This was then followed up on **18<sup>th</sup> August 2011** with an announced for peace talks. Four months later, the KNU held an emergency CSC meeting on 8-11 November 2011 to discuss this invitation to peace talks and it was during that meeting that the KNU decided to join the peace process. At the emergency CSC meeting a 7 members **Peace Building Committee** was formed, whose mandate was to handle the peace process and respond to the Governments announcement and call for peace talks. The committee consisted of:

For the first time, representatives of 17 armed ethnic opposition groups were able to meet in Burma with the consent of the Government. KNU representatives were - KNU Chairman, General Mutu Sae Poe; General Secretary, P'doh Saw Kwe Htoo Win and Political and Military Affairs Advisor to the Chairman, Col Saw Htoo Htoo Lay.</p> <p>For its part, the WGEC, through the RCSS and KNU, presented its framework to the Government on 31 August 2013 and prepared a Nationwide Ceasefire Agreement. With concerns mounting over different positions within the armed ethnic opposition, the KIO arranged for a conference that would bring all sides together. The main aim of the conference was to discuss the way forward in relation to not only a nationwide ceasefire but also to the Government's assurance of political dialogue in the future.</p> <p>The KNU and RCSS had already outlined what they wished to see prior to the conference in an 8-point statement:</p> <ol style="list-style-type: none"> <li>1. In order to begin a political dialogue, the Government of Myanmar has invited ethnic armed groups to sign a nation-wide ceasefire.</li> <li>2. To prepare for the political dialogue, the KIO has invited ethnic armed group leaders to an Ethnic Armed Group Conference.</li> <li>3. On 31 August 2013, the KNU and the RCSS proposed a Framework for a Political Dialogue, developed jointly by the armed groups, to the Union Peacemaking Working Committee.</li> <li>4.
